Woodland Trust Update:

Significant discussion took place regarding the draft leaflet provided by Jill Aitken Woodland Officer, comments made by the group to be incorporated and draft returned to Jill for printing.

Format of leaflet, suggest A3 gatefold.

Have removed reference to recreational access in association with the restoration of the peat crown.

Regarding restricted access, those present agreed it should be the responsibility of the Contractors to post signage at the 2 entrances to the Moss. A clear Yes or No policy should be applied.

Alternative Route, this has been discussed by Jill with members of the group, runs behind pumping station into the Moss onto Drysdale march returning to the Moss adjacent to the covered seat. KMcD to contact NE water and advise.

Suitability, the group require assurances from the WT that this alternative route including bridging is suitable, and that existing insurance cover will apply. If such assurances are not possible the group consider that the Moss should be closed for duration of works.
