**Orchard:** Louise met Tara in Orchard and discussed planting of new fruit trees and some trimming of native trees (these can not be removed) which are shading existing fruit trees. 2 sites have been agreed with WT and will be fenced off (WT no longer using plastic guards), then we can plant.
