Experiments on systems in nature are notoriously difficult. As we all know, the normal variations in the subject as well as the variability of environmental influences means that carefully planned experiments are required to separate out the effects and reach valid conclusions. As you know we have been clearing Birch and brash from the top of the Moss for years. After our first 'experiment' in one corner of the Moss lead by Roy over 15 years ago. We have cleared much of the crown of the Moss while improving our technique and organization but more importantly collecting data over all those years. We're glad that the WT has the expertise for this and we would very much like to see your experimental protocol: could you send it to us please?

These 3 topics are all inter-related and it makes sense to cover all of them at one meeting. No response or acknowledgement from the 4 recipients. Not unexpected: we've asked several times for a meeting to discuss the vision and management plan and the WT have never replied to any request. In October our NuCo working group specifically asked the WT what they wanted to get out of a new arrangement and again, no response. For NuCo, we've done our work so we'll just keep it on file in case the idea ever crops up again. (Update, as of 16 April, = 6 weeks, still no response from WT).

Facebook records details of who is following us. At present 24% are male and 76% female.

We have 540 followers who live as follows..
